**MOTION 2020-26:** Moved by Terry Carwile, seconded by Todd Jourgensen, That the Board of Trustees approve Resolution 2020-02 AUTHORIZING THE ISSUANCE OF A TAX ANTICIPATION NOTE, SERIES 2020, IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$600,000 FOR THE PURPOSE OF PROVIDING A TEMPORARY SOURCE OF CASH FOR THE PAYMENT OR REIMBURSEMENT OF THE DULY BUDGETED AND APPROPRIATED EXPENSES OF THE BOARD IN ANTICIPATION OF THE RECEIPT OF PROPERTY TAX REVENUES IN THE YEAR 2020.

## **Approval of Resolution 2020-27.**

MOTION 2020-27: Moved by Terry Carwile, seconded by Don Myers, That the Board of Trustees approve A RESOLUTION AUTHORIZING THE EXECUTION AND DELIVERY OF A CREDIT AGREEMENT BETWEEN THE BOARD OF TRUSTEES OF MEMORIAL HOSPITAL AND GREAT WESTERN BANK IN CONNECTION WITH THE ISSUANCE BY THE BANK OF A REVOLVING LINE OF CREDIT TO THE BOARD WITH A CREDIT LIMIT NOT TO EXCEED \$1,500,000; AUTHORIZING OFFICIALS OF THE BOARD TO EXECUTE A NOTE, PLEDGE AGREEMENT AND SUCH ADDITIONAL DOCUMENTS, AND TO TAKE ALL ACTION, AS NECESSARY TO CARRY OUT THE TRANSACTIONS CONTEMPLATED HEREBY, AND PROVIDING FOR RELATED MATTERS.
